





What is AudioEye

AudioEye is a digital accessibility platform that improves accessibility and minimizes risk for digital surfaces, including websites. By using a technology-first approach to deploy automation with expert services, AudioEye provides a complete accessibility solution for businesses of all sizes at an affordable price. AudioEye meets U.S. and global accessibility standards, including ADA and WCAG 2.1.

What is the ADA?

The Americans with Disabilities Act (ADA) is a landmark civil rights law that prohibits discrimination against individuals with disabilities in all areas of public life. It gives millions of individuals with disabilities equal access to all public and private places, from employment to government, telecommunications, and businesses. Title III of the ADA addresses businesses specifically. It prohibits discrimination based on disability in places of public accommodation, which includes restaurants, schools, offices, and more. Companies are required to make "reasonable modifications" to serve people with disabilities.

Why would a client need AudioEye?

First, to comply with the Americans with Disabilities Act (www.ada.gov), a national law that prohibits discrimination against individuals with disabilities in all areas of public life, including digital websites. Second, to expand your audience to users with disabilities: every fourth adult in the U.S. has a disability that can prevent them from using your website and purchasing your services. You can expand your digital presence by making your website accessible with AudioEye.

As of today, this software runs via JavaScript or integrated plugins, which provide a codeless installation experience.

Who needs to be compliant?

Under Title III of ADA, businesses "open to the public" both in the physical world and online are required to provide equal access to people with disabilities. All site owners are responsible for reviewing and complying with local legislation applicable to site visitors.
